EXTREME ONE-COAT STUCCO



PARAGON EXTREME ONE COAT: is a

proprietary mixture of portland cement, sand, fibers and proprietary ingredients that is reinforced with wire fabric or metal lath and applied over sudstrates of expanded polystyrene (EPS) insulation board, extruded polystyrene (XEPS) insulation board, fiberboard, plywood, gypsum sheathing, masonry or concrete. Extrene One Coat is installed on exterior walls of woodframe, masonry or concrete construction.

USES:

• Wood frame walls • Masonry/Concrete

PREPARATION: Lath shall be applied in accordance with code requirments. Porous, uncoated stucco/plaster, concrete and masonry

must be properly cured, clean, dry and free of dust or any other contaminants. Level surfaces if necessary to required tolerances prior to application with appropriate leveling material.

MIXING: Add 5-7 gallons clean, potable water per 80 Lb. (36.2kg) bag to a machine mixer. Add 80 Lb. Extreme One Coat Stucco and 215 Lbs. Of clean palster sand and mix 6-8 minutes to a smooth working consistency.

PLACEMENT:

- After placing Extreme One Coat Stucco tamp mix with rod or stick.
- Apply Extreme One Coat Stucco by hand or with machine (gun).
- Trowel to a 3/8" to ½: thickness.
- Rod or darby the surface to achieve a smooth and level plain.
- Texture may be applied as soon as material is set sufficiently to recieve it..
- For sand or synthetic finishes the surface should be floated to a vaery level plain.

COVERAGE:

• 80-90 Sq. Ft. Per 80 Lb. Bag at 3/8" to ½" thickness. Coverage may vary depending on surface conditions and application technique.

CURING:

When damp curing, lightly and evenly fog the surface, do not use excessive water. Wals must be protected from rain, snow, and frost for a perioad of 48-72 hours or streaking and efflorescence may occure.

PACKAGING:

80 Lb. Bag (36.2 kg) 40 per pallet

LIMITATIONS:

 DO NOT apply when the air or substrate temperature is below 38° F within 24 hours

LIMITATIONS CONTINUED:

- **DO NOT** over water.
- **DO NOT** over mix.
- **DO NOT** apply over substrates that are frozen or contain frost.
- **DO NOT** use dirty water or tools.
- DO NOT add or mix any materials with this product unless approved by Paragon Building Products Inc.
- Expantion joints are recommended every 144 sq. Ft. (13m²) maximum, at dissimilar substrate, at existing joints in the substrate and at floor lines in mutilevel construction.
- Base should be kept moist for at least 24 hours after application.
- Application in cold or damp weather will increase the chance for the occurrence of efflorescence. Efflorescence occurs naturally and is beyond the control of Paragon.

FOR BEST RESULTS:

- Maintain a consistant mix ratio of water/dry ingredients form batch to batch.
- Maintain a consistent application through out the project
- Uniformly dampen the base plaster to ensure consistent drying of the coat.
