# PRODUCT INFORMATION 50# TRAVERTINE POLYMERIC SAND



#### **TRAVERTINE POLYMERIC SAND:**

is a specially formulated mixture of ASTM C-33 #90 grit silica sand and proprietary products used specifically for travertine paver systems.

#### **USES:**

- For the installation of travertine pavers
- For filling travertine paver joints
- For filling surface voids on pavers

#### **BENEFITS:**

- Polymer Modified for hardening and flexibility
- Enhances the beauty of travertine pavers
- Increases paver stability
- Prevents dirt and debris build-up
- Color matched for dark & light pavers

**MIXING:** Before broom spreading sand over pavers and into joints the sand should be dry mixed first in a mixing container so that all the chemicals are evenly distributed throughout the mix. This process will ensure that the polymeric sand will perform at an optimum level.

**SPREADING:** After dry mixing the polymeric sand, it can then be applied in even piles on the paver deck and then carefully brushed into the joints and voids. It is necessary to ensure that any extra sand residue is removed from the smooth flat surfaces before applying water for hardening.

**WATERING:** It is recommended to use an adjustable hose nozzle set on mist for moistening the polymeric sand. Allow about 15 to 20 minutes between watering and repeat process up to 3 times.

#### **COVERAGE:**

50 lbs. provides approximately 300 to 800 square feet depending on size of paver and joint size

**SHELF LIFE:** One year from date of manufacturer.

**STORAGE:** Store in a tightly closed container off the floor in a dry place.

PACKAGE: 50 Lb. bag (34 kg)

**COLORS:** Tan, Mocha and Silver

- **DO NOT** add or mix any materials with this product unless approved by Paragon Building Products Inc.
- Application in cold or damp weather will increase the chance for the occurrence of efflorescence. Efflorescence occurs naturally and is beyond the control of Paragon.
